Information Collection

Registration:

In order to become a Chuck's Fire Extinguisher Service Co. user, you must first create an account on this web site. To create an account you are required to provide the following contact information: name, email address, country, ZIP/postal code, and billing information.

Profile Information:

Once a user, you may order recordings and signs. You may also choose to manually record all your own information.

All information that you record and all leads generated will be covered by the same terms of this privacy policy as cover your own personally identifiable information.

Cookies & Log Files:

Like most web sites, Chuck's Fire Extinguisher Service Co. uses cookies and web log files to track site usage. A cookie is a tiny data file which resides on your computer which allows Chuck's Fire Extinguisher Service Co. to recognize you as a user when you return to our site using the same computer and web browser. Unfortunately, if your browser settings do not allow cookies, you will not be able to use our website. Like the information you enter at registration or in your Profile, cookie and log file data is used to customize your experience on the web site.
